## RELEASE AND INDEMNITY (FOR AGE BELOW 18)

By this Release and Indemnity made between me, the undersigned, the parent or legal guardian of \_\_\_\_\_ (called "my child" thereafter) and the Hong Kong Aviation Club Limited (called "HKAC" thereafter) on its own behalf and all persons to whom these releases and indemnity are expressed to be granted and made in consideration of my child being carried at my request as a pilot, passenger or student in any aircraft owned and/or operated by HKAC and being permitted to enter the premises occupied by HKAC, I, for myself, for my child, for my and my child's estate, personal representatives and dependants (collectively called "the Releasers") do hereby release and discharge HKAC, its present and future members, officers, agents, servants, employees and others authorized by it and their and respective estates and the pilot-in-command of the aircraft from all claims and causes of action of any nature that the Releasers (and any of us) may at any time have against them (and any of them) in respect of any injury, illness or disease (including injury, illness or disease resulting in death) and whether such be mental or physical or both whenever manifesting itself and howsoever the same may be caused sustained or contracted by my child or me before, during or after any flight in any such aircraft or in other way resulting directly or indirectly from the presence of my child in or near any such aircraft and for any loss of or damage to (howsoever caused) my or my child's personal belongings suffered at any time whilst in or near any aircraft owned or operated by HKAC and/or whilst on or near any premises occupied by HKAC and, in all cases, any losses consequential thereon.

And I further agree that I and my estate will at all times fully and effectually indemnify the HKAC against all actions, claims and demands (including legal costs and expenses on a full indemnity basis) that may be made against them arising out of or in any way consequential upon any such injury, illness, disease, loss or damage howsoever the same may have arisen.

## 責任解除及豁免賠償協議書（18歲以下人士適用）〔譯本〕

2. TERMS AND CONDITIONS 條款與細則

- ➔ Trial (Youth) Membership is open to persons considering learning to fly in Hong Kong and shall be valid for one flying lesson only.  
體驗飛行（青年）會籍是為有志於在香港學習飛行之人士而設，其只能有效於單一次之飛行體驗，待是次飛行完成後，該會籍便會自動被取消。
- ➔ No person, who has previously had a Trial (Youth) Membership or had any other form of Membership of the Club, shall be eligible for the Trial (Youth) Membership.  
任何人士均不得多次擁有體驗飛行（青年）會籍或於擁有該會籍前已擁有其他任何形式之本會會籍。
- ➔ Trial (Youth) Members shall be at least 14 years old. Consents are required, by reading and signing the "Release and Indemnity Form (For Age Below 18)" printed on the back, from their parents or legal guardians before undertaking their flights.  
所有體驗飛行（青年）會員必須年滿十四歲及已獲其父母或合法監護人之允許。而其父母或合法監護人必須於其子女飛行前細閱及同意接納背後所列之“責任解除及豁免賠償協議書（18歲以下人士適用）”，並親自簽署作實。
- ➔ Trial (Youth) Members shall not be given credit but must pay in cash or by credit card for their flying lesson.

- ➔ Trial (Youth) Members shall have no rights or privileges in the Club.
