Launch of HKACC Testimonial Scheme

The Hong Kong Air Cadet Corps is committed to fostering the personal and professional growth of all our members. To help cadet and adult members formally record their achievements and experiences within the Corps, we are pleased to launch the **HKACC Testimonial Scheme** (the Scheme).

This initiative consolidates each member's service record, including training completed and awards received over the years, into an official Testimonial. This document will serve as a valuable resource for applications related to further education, employment, immigration, and other purposes of our Corps members.

Key Features of the Scheme and Application Procedure:

1. The Testimonial will categorize applicants into one of the three **Training Paths** as applicable:
 - a. **Government Flying Service (GFS)**,
 - b. **Civil Aviation, or**
 - c. **Disciplined Services**.
2. All Corps members, both cadet and adult members, are eligible to apply. Applications are accepted throughout the year.
3. Interested members should complete Form "**HKACC_VQU_TESTRE**" and email it, along with all the required supporting documents, to VQU for processing. Documents should be sent to: ebenezer.kong@aircadets.org.hk **AND** cc: winnie.ho@aircadets.org.hk.
4. Applications must be signed by the applicant and endorsed by their respective OC Units for verification.
5. Approved Testimonials will be *officially stamped* and further verified by HKACC Headquarters.
6. Documents will be ready for collection within 7 to 14 working days after VQU receives all required application materials. Email notifications will be sent to applicants once their documents are ready for collection.
7. Your personal data will be handled in strict compliance with the Personal Data (Privacy) Ordinance and all other applicable privacy regulations.
