No 1 Qualified Aviation Instructor Course (QAIC)

Extension of Deadline and Revised Entry Requirement for Cadets

My previous memo regarding No 1 QAIC dated 27 January 2017 (Reference: (2) in AE/QAIC) refers. This memo serves to announce the deadline extension for cadet applicants and the revised entry requirement for cadets.

2. The application deadline for **cadets** has been extended to 25 February 2017 (Saturday) 1800 hours. Interested cadets should complete the attached application form and return it by email (address: hkacc.aewing@gmail.com) via their OC Unit. The course fee of HK\$200 shall be settled by submitting a cheque payable to “HONG KONG AIR CADET CORPS” and the cheque shall reach HQ before the aforementioned time. The cheque shall be marked at the back with applicant’s name, rank, unit and serial number. Incomplete applications or applications not following the instructions may not be considered.

3. In the meantime, the application for members other than cadets has been closed.

4. One of the criteria for cadets to enroll in QAIC was to achieve a classification of Leading Cadet or above. In view of the recent enquiries and subsequent to consideration, First Class Cadets may still apply for this course, provided that the concerned OC Unit could confirm in writing to the undersigned that the cadets could achieve the classification of Leading Cadet by 1 May 2017. First Class Cadets may be accepted as probationary participants. In case any probationary participants failed to advance to Leading Cadet by 1 May 2017, they will not be assessed at the end of QAIC. In any case, the course fee will not be refunded.

5. Cadets are reminded that this is a one-off arrangement and may not be repeated in the future.

6. Members who have applied before the original deadline need not re-apply.
